INVESTIGATION

May 24, 2001, 2023 HOURS

On May 24, 2001, Officer D. Sanchez was dispatched to 801 Kentucky SE reference a sexual molestation offense. When he arrived he spoke with Bernadette Johnson. Ms Johnson appeared to be very upset and was crying. She stated she did not know what to do because her boyfriend, Chris, touched her daughter inappropriately.

Officer Sanchez spoke with Ms. Johnson's daughter V [REDACTED] (7 year old juvenile). V [REDACTED] advised, last Wednesday, May 16, 2001, and this past Wednesday, May 23, 2001, her mother has been attending a Kayaking class at Highland High School. V [REDACTED] stayed with Chris while she attended these classes. V [REDACTED] advised Chris had her take off her underwear and he would spank her. After he would spank her he would rub her butt. She also advised Chris would make her pose in several positions. One of the positions would be to place her hands on her dresser with her feet spread apart. He also had her lay on the bed with her feet and legs in the air. She indicated she did not have her underwear on at the time.

Ms Johnson indicated she was upset because when she and Chris are sexually active, Chris spanks her. Ms Johnson confronted Chris, asking him if spanking V [REDACTED] turned him on. He replied, "not really". Ms Johnson further advised Chris is constantly on the Internet and he has been down loading pornographic pictures of women dressed as little girls, as well as photos of them being spanked and caned.

Chris Tape was advised the Miranda warning and he spoke with Officer Sanchez. He advised while he was watching V [REDACTED] she began acting up, because he would not let her call her friend. He then had her take off her pants and underwear and spanked her with the belt. He then rubbed her butt with his hand to check for welts. He stated the reason he spanked V [REDACTED] was to discipline her. Tape filled out a hand-written statement.

I was assigned this case on May 25, 2001 I set up a Safehouse interview for V [REDACTED]. The Safehouse interview was done on June 7, 2001. V [REDACTED] was interviewed by Forensic Interviewer, Michelle Aldana. V [REDACTED] disclosed the same information she had told Officer Sanchez however, she did not say Chris rubbed her butt after he spanked her. She did elaborate that Chris called it "punishment for nothing" and she also indicated she did not do anything wrong for him to be spanking her. She advised he spanked her with the belt and with his hand. When he would finish he would say "punishment's over". The first time he spanked her he put her over his knee. He also made her lay on the bed with her legs in the air. When she was in the position with her hands on the dresser, she advised, he would just look at her. She went on to say Chris would make her count the

spankings he gave her and make her change positions. She remembers counting to 5 or 6. The second Wednesday that he spanked her she decided to tell her mom he was spanking her.

I interviewed Ms Johnson while at the Safehouse. She advised me she no longer lived with Chris and when she left she took the pornographic items Chris was obsessed with. She gave these items to me to look at. As I looked through the items, I noted numerous magazines portraying photographs of child like pornography. The magazines were titled "Barely Legal". There was also a selection of Kane magazine, which refers to spanking fetishes, as well as numerous other magazines depicting women being restrained and spanked. There was also a selection of videos of the same nature.

I also viewed a videotape, which appeared to be a home video of Christopher Tape and an unidentified female. The female was blind folded with a cloth. Both Tape and the female are unclothed. The video displays Tape striking the female with what looks like a cane like instrument. He struck the female across her buttock area over 15 times. Each time Tape struck the buttock area, he would rub the area with the palm of his hand. I noted red marks about the female's buttock area. The female would repeatedly say "Thank you sir may I please have another".

Ms Johnson advised when she confronted Chris about spanking V [REDACTED] he initially denied any wrong doing but later told her he needed some help. Ms Johnson spoke of their sex life, indicating, the only way Chris could become sexually excited is if he spanked her prior to intercourse. He would spank her with his hand or a brush. Bernadette went on to say, when she and Chris first got together he did not spank her, however, the longer they were together, the more he began to display these behaviors.

On July 5, 2001, an arrest warrant was obtained for Christopher Tape. Tape was located at his place of employment, the Bernalillo County Detention Center. He accompanied me to the Main Police Station. I explained to him why I needed to speak with him and he indicated he would like to have his attorney present before he made a statement or answered questions. Tape was walked over to the Detention Center and booked with the original warrant.

This case is being submitted to the Bernalillo County District Attorney's office for review and the prosecution of Christopher Tape for the charges of Criminal Sexual Contact of a Minor (6 Counts).
